Whereas, it is the desire of the Partners to enter into a joint project for the installation of a new water main connecting to the Louisville Water Company master meter located near HWY 1604 and 245 intersection in which the water main shall be constructed through the North Nelson Water District service area along Hwy. 245 to the Bardstown City limits on Hwy. 245.

Whereas, this water main project is intended for use of North Nelson Water District and the City of Bardstown to aid in providing additional water supply for Nelson County,

Whereas, the Nelson County Fiscal Court will provide a total of Five Million Dollars [\$5,000,000 (\$1.7 million from the KIA Grant and \$3.3 million from the Nelson Fiscal Court American Rescue Funds)] toward the construction of said water main with the design coordinated with the Partners,

Whereas, any additional funds and/or grants shall be paid toward the project balance after deduction of the Nelson County Fiscal Court contribution with the remaining balance of the cost of the water main construction equally shared by the North Nelson Water District and the City of Bardstown.

Whereas, the project bidding, oversight, future maintenance, and ownership of said water main shall belong to the North Nelson Water District and therefore joining into a water sales agreement with the City of Bardstown,

Now therefore, the Nelson County Fiscal Court in signing this agreement, we hereby support the water main project as outline and commit to the conditions as noted.

CONDITIONAL CONTRACT OF EMPLOYMENT

THIS AGREEMENT, made and entered into the 18th day of August, 2021, by and between the COUNTY OF NELSON, a County Government, by and through the Nelson County Sheriff (hereinafter "NCSO"), or his duly appointed designate, party of the first part, and **William J. Purdom**, party of the second part.

WHEREAS, it is necessary to train, and provide salary and other benefits to the second party, and on the job field training at the Nelson County Sheriff's Office, for a total training period not to exceed 12 weeks and,

WHEREAS, the parties acknowledge that said payment of Training Reimbursement Contract to the City of Lebanon, training, salary and other benefits will be for a period of time, during which second party is not performing regular duties as a deputy sheriff of the NCSO.

NOW, THEREFORE, the parties enter into the following agreement:

1. The first party shall pay Training Reimbursement Contract to the City of Lebanon, train, equip, and provide salary and other benefits to second party to provide the elements necessary for second party to qualify as a deputy sheriff for the NCSO at a cost of \$24,861.74, the cost to the Nelson County Sheriff's Office for payment of Training Reimbursement Contract to the City of Lebanon, and equipment for said period of 12 weeks.

2. First party shall advance necessary expenditures for the Training Reimbursement Contract to the City of Lebanon, training, equipment, and salary to second party.
3. Second Party agrees to receive and successfully complete said training and to become a Deputy Sheriff of the NCSO.
4. Second Party shall continue to work for first party as a Deputy Sheriff with duties assigned to him by First Party for a period of two years after field training is complete. The two years shall begin on August 18th, 2021, and shall terminate on April 18th, 2023.
5. Second Party shall have the option of paying for the above sum of \$24,861.74 in cash within 90 days of successful completion of the training course or he may pay said sum of \$24,861.74 by remaining and continuing as a Deputy Sheriff in good standing with the Nelson County Sheriff's Office. This fee shall not be prorated. Upon successful completion of the duties of a Deputy Sheriff of the Nelson County Sheriff's Office for two years after completion of the Field Training Program, the indebtedness herein mentioned shall be null and void. Termination date is set for April 18th, 2023.
6. If the Second party leaves the NCSO prior to August 18th, 2023 to work with another law enforcement agency, pursuant to KRS 70.290, the new agency shall reimburse the Nelson County Sheriff's Office for the actual costs incurred and expended by the NCSO which are associated with the initial hiring of the second party, including but not limited to the application process, training costs, equipment costs, salary and fringe benefits from the time of the first party's initial application until graduation from the Field Training Program. The second party must make any other employer aware of this provision prior to accepting any other employment.
